Re – BT Pensioners Reconnect - a new website specifically for BT Pensioners

I am writing to you in hope and anticipation that you will be able to help me to engage with an appropriate person within the BT Pension Scheme (BTPS) organisation. I have failed to get any help using the contact email address given in the BTPS Website and the website does not provide any other means of access into the organisation.

I am a BT Pensioner following a long career in BT. Since I retired I have often felt the need to meet up with former colleagues, but like so many of us I have lost contact with most of the people I used to know. I have always felt that a website specifically For BT Pensioners would be an ideal solution. I know that there are a number websites out there that aim to find friends and colleagues, but I find that they just do not deliver.

So I have designed and launched a website www.btpensionersreconnect.co.uk (BTPR.) It's primary objective is to enable pensioners to make contact with former colleagues by members voluntary registrations adding to a database that can be searched by members. It will only function effectively when there is a large database of members. The site funded by me personally, it is non-commercial and no membership fees are payable. To avoid a lengthy description I suggest that you visit the site to understand what I'm trying to achieve.

I now need to talk to someone in BTPS about publicising the website in BT Pension Scheme correspondence and other communications with it's pensioners. Interestingly, I have recently polled a random selection of 50 of my members asking if they would like to see the website publicised by BTPS and a response of over 50% was achieved of which 100% answered Yes!

I have had the support of BT Today Magazine with a feature in the November 2011 issue (copy enclosed) and the BT Group editor in chief has said "*This website provides an excellent social networking platform for BT people to stay in touch after they have retired, and I am delighted to help spread the word that it has gone live*" With more than 1100 members already, who believe that BTPR is a great idea, I think you will agree that I have demonstrated that there is a genuine need for a website such as BTPR. Also that this website does provide a useful service to pensioners and I am sure that you will recognise the benefits to members and realise that BTPS is uniquely positioned to offer assistance at virtually no cost.

Thank you for your letters, dated 1 and 8 February, respectively, which have been passed to this office by Accenture HR Services.


I am pleased to hear that your new website is receiving positive feedback and gaining interest with BT pensioners.
